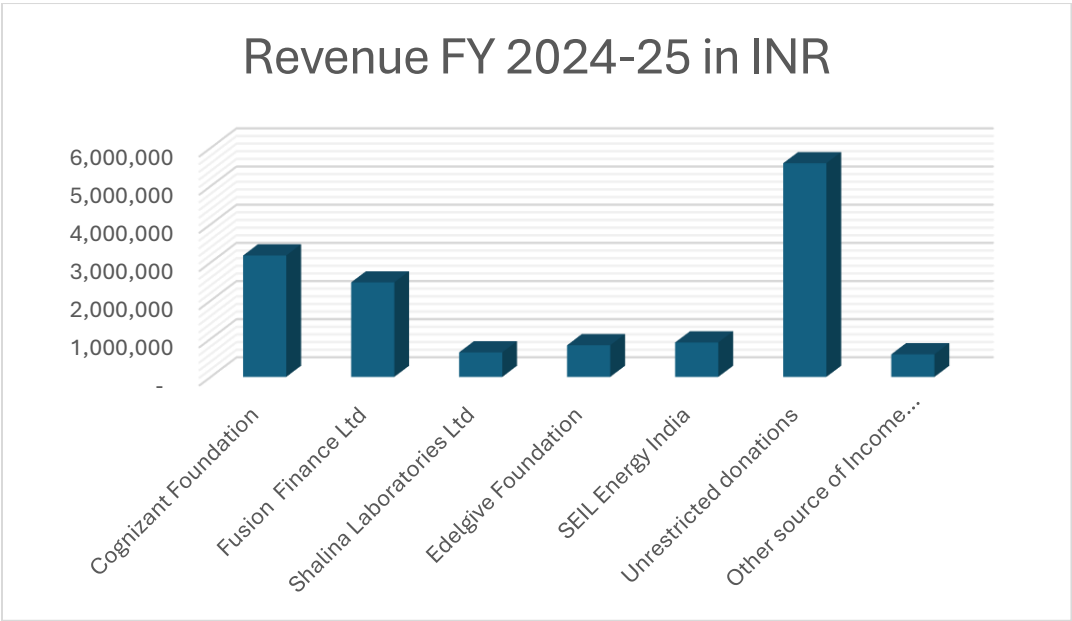

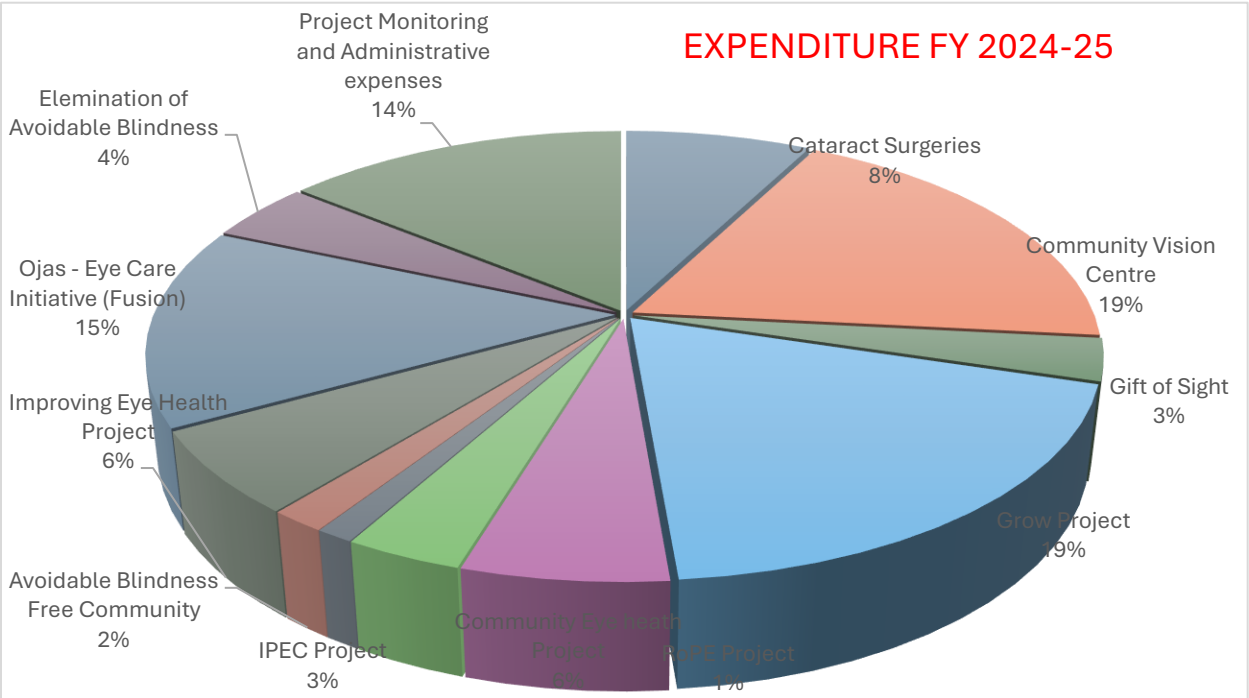
In 2024, we reflected on our past achievements while looking ahead to the future as we developed our **2024–2028 Global Strategy**. We have set ambitious goals that require strategic investments across all aspects of our operations.

Thanks to the generous contributions of both long-term and new supporters, our revenues in FY 2024–25 surpassed **INR 14.22 million**. We are especially grateful to our corporate and institutional partners such as **Cognizant Foundation India, Fusion Finance Limited, EdelGive Foundation, Shalina Laboratories Ltd., and SEIL Energy India**, whose support enabled us to implement specific project activities—including setting up and running Vision

Centres, conducting School Eye Screening Programmes, and supplying spectacles. Contributions from individual donors also significantly strengthened our efforts.

We continued to build and strengthen partnerships with institutional and corporate supporters, which accounted for more than **56% of our revenues**. During the year, we also welcomed several new partners—including **SEIL Energy India, Abhay Dan, and VisvaProTec Pvt Ltd.**—who are now supporting our community eye health initiatives.
